St Leonards Primary School is looking forward to another year of quality teaching and learning for your child. We would like to advise you of St Leonards Primary School's voluntary financial contributions for 2023.

Schools provide students with free instruction to fulfil the standard Victorian Curriculum.

The ongoing financial support of our families ensures that our school can offer the best possible education and support for our students.

Within our school this support allows us to purchase ongoing supplies and equipment for all learning areas including consumables for Art, STEAM and Inquiry Learning projects, and to provide every child with a school diary. We are also able to buy new library books and maintain up to date computers and iPads on a 1:1 ratio, provide special curriculum experiences and enhance our Kitchen Garden program. Subscription costs to the MARC Program and for iPads have both increased by \$10 this year.

We are proud of the level of support we provide our students, but based on the uptake of voluntary financial contributions this year, we do not believe that we will be able to continue this level of support going forward.

We received financial support for only 26 of our 130 students in 2022.

We rely on your contributions in 2023.

FREE INSTRUCTION

- Schools provide students with free instruction and ensure students have free access to all items, activities and services that are used by the school to fulfil the standard curriculum requirements in Victorian Curriculum F-10, VCE and VCAL.
- Schools may invite parents to make a financial contribution to support the school.

PARENT PAYMENT REQUESTS

Schools can request contributions from parents under three categories:



Curriculum Contributions

Voluntary financial contributions for curriculum items and activities which the school deems necessary for students to learn the Curriculum.

Other Contributions

Voluntary financial contributions for non-curriculum items and activities that relate to the school's functions and objectives.

Extra-Curricular Items and Activities

Items and activities that enhance or broaden the schooling experience of students and are above and beyond what the school provides for free to deliver the Curriculum. These are provided on a user-pays basis.

• Schools may also invite parents to supply or purchase educational items to use and own (e.g. textbooks, stationery, digital devices).



FINANCIAL HELP FOR FAMILIES

- Schools put in place financial hardship arrangements to support families who cannot pay for items or activities so that their child doesn't miss out.
- Schools have a nominated parent payment contact person(s) that parents can have a confidential discussion with regarding financial hardship arrangements.



SCHOOL PROCESSES

 Schools must obtain school council approval for their parent payment arrangements and publish all requests and communications for each year level on their school website for transparency.
